



**ENDORSEMENT OF DEATH/ DIVORCE OF FIRST WIFE
AND RE-MARRIAGE WITH SECOND WIFE**



The ESM is required to submit an application along with requisite documentary proof to Naval Pension Office (NAVPEN) duly attested by concerned Zila Sainik Board (ZSB). Post Verification, ZSB is required to forward the application to NAVPEN.

Documentary Proof to be Submitted along with Application through Concerned ZSB/RSB:

1	Original Divorce Deed with First Wife issued by competent Court of Law or Attested copy of Death certificate of First Wife, as applicable.
2	Attested copy of Marriage Certificate or Original Court Affidavit ascertaining Marriage (along with date of marriage) between the ESM and his second wife attested by First Class Magistrate.
3	Original Court affidavit having details of ESM & Second Wife seeking Marriage Declaration. (Sample Affidavit enclosed)
4	Attested copy of Birth Certificate or X th Matriculation Certificate along with attested copy of Aadhaar card/ PAN card of wife.
5	Copy of Discharge Book/IN-271
