**DIRECT RECRUITMENT OF CHARGEMAN-II(REDESIGNATED AS CHARGEMAN)**  
**ISSUE OF CALL LETTERS FOR WRITTEN EXAM**

1. Refer to the Notifications published in the Employment News dated 16-22 Apr 2016 inviting applications for the post of Chargeman-II(re-designated as Chargeman) to fill 102 posts by Direct Recruitment.
2. The written examination will be conducted in Five (05) sessions group-wise i.e Engineering/Construction/PP&C/Electrical and Weapon from 16 Dec 2016 to 18 Dec 2016 **at Dr. YSR ACA-VDCA Cricket Stadium, Pothinamallayya Palem, Visakhapatnam.** The schedule for the examinations are as appended below:-

3. Based on the applications received, call letters for all eligible candidates have already been dispatched for appearing in the above Written Examination by post on 16 Nov 2016. A Specimen copy of call letter is placed at Annexure-I.
4. Candidates whose names are appearing in the list, but not received their Call Letters for the Exam are advised to undertake the following:-
- (a) Check their names in the eligibility lists under respective group applied for.
- (b) If the name is appearing in the list take the screen shot of the list, where the name is appearing, download the Specimen Call Letter for the respective group examination from the website. Fix a recent passport size photograph and self-attest the photograph on the call letter.
- (c) Duly fill all the details viz., Roll No., Name, Address, Category (UR/OBC/SC/ST), Sub-Category (PWD/Ex-SER/SPORTS), Group for which appearing the written examination. Gate, Stand and Seat Number will be provided at the venue and **such candidates are required to be present at the venue by 0700hrs for Morning session exams and 1100 hrs for Afternoon session Exams as per the Group and schedule promulgated at Para 2 above.**

Names of the candidates found **Ineligible** view not full filling the eligibility criteria as prescribed in the Notification/Advertisement published in the Employment News dated 16-22 Apr 2016 is also uploaded herewith in PDF format along with the reasons of the grounds for rejection. However, no further communication from candidates found Ineligible will be entertained.
