3. The candidates will be considered for appointment subject to outcome of the appeal at High Court (Hyd)).

4. The last date for receipt of applications, as per the Annexure to Notification referred at Para 1 above, is extended by further period of 21 days from the date of publication of this Corrigendum in the Employment News.
