WAIVING OFF REQUIREMENT OF JOINING DUTY AT LEAST FOR A DAY BEFORE BEING RETIRED/RELEASED FROM SERVICE – COVID-19 MEASURES

I am directed to refer to GOI, Ministry of Defence, Department of Military Affairs (DMA) letter No. B/33940/AG/PS-2(b)/DMA(AG-II) dated 01 May, 2020 and to state that the Competent Authority has approved to waive the existing mandatory requirement of joining duty at least for a day before proceeding on retirement/release in respect of Navy personnel who are due for retirement/release from service and are presently on leave and unable to report to their units owing to order of GOI/State Government/local authorities/Service Hqrs, on account of anti-COVID 19 measures. As a result of this, Navy personnel who are attaining the prescribed age or service of superannuation/release shall be considered retired/released from service on the due date, till such time the situation improves or till further orders, whichever is earlier.
