FILLING INSTRUCTIONS

1. The individual should draw lines across the blank space below the last entry to prevent insertion of any name after he has signed.
2. In case of married personnel, an individual may nominate dependent Mother/Father/Brothers/Sisters with provision that their aggregate share should not exceed 33 $\frac{1}{3}$ % of total benefits. However, if the nomination is made in excess of 33 $\frac{1}{3}$ % of total benefits, the same shall be restricted to 33 $\frac{1}{4}$ % only and the rest 66 $\frac{3}{4}$ % of the aggregate share would be assigned to the nucleus family, i.e. wife/husband/son/daughters.
3. **File fresh/revised nomination immediately on occurrence of any casualty viz. marriage, divorce, death of the nominee.**
4. **In case fresh nomination on account of casualties mentioned at serial 3 above is not received, Marriage Certificate, Court Order, Second/Alternate Nominee (on account of Death of the nominee/s), Succession Certificate as applicable would have to be produced. Decision of NGIF Administrators on requirement of documents as mentioned here would be final.**
