Part I - General information

- 1. <u>Last date and time for depositing the Bids</u>: 22 Aug 18 (Wednesday), 1430 hrs. The sealed Bid should be deposited/reach by the due date and time. The responsibility to ensure this lies with the Bidders.
- 2. Manner of depositing the Bid: Sealed Bid should be dropped in the Tender Box marked as WESEE TENDER BOX at the address given above so as to reach by due date and time. Late tenders will not be considered. No responsibility will be taken for postal delay or non-delivery/ non-receipt of Bid documents. Bids sent by FAX or email will not be considered (unless they have been specifically called for by these modes due to urgency).
- 3. <u>Time and date for opening of Bid</u>: 22 Aug 18 (Wednesday), 1500 hrs. (If due to any exigency, the due date for opening of the Bids is declared a closed holiday, the Bids will be opened on the next working day at the same time or on any other day/time, as intimated by the Buyer).
- 4. <u>Location of the Tender Box</u>: Ground Floor, West Block 5, RK Puram, New Delhi. Only Bids that are found in the WESEE tender box will be opened. Bids dropped in the wrong Tender Box will be rendered invalid.
- 5. <u>Place of opening of the Bid</u>: WESEE, Ground Floor, West Block 5, RK Puram, New Delhi. The Bidders may depute their representatives, duly authorized in writing, to attend the opening of Bids on the due date and time. Rates and important commercial clauses quoted by all Bidders will be read out in the presence of the representatives of all the Bidders. This event will not be postponed due to non-presence of your representative.
- 6. <u>Type of Tender and Bid</u>. This is an <u>Open Tender Enquiry</u> and <u>the bids will</u> <u>be accepted/ entertained by this office in accordance with GFR 2017</u>. This procurement is on <u>Single Bid</u> basis where both the technical and commercial details, along with other information, as sought are to be submitted together in a single sealed cover by the bidder.
- 7. **Forwarding of Bid**: Bid should be forwarded by Bidder under the original memo / letter pad inter alia furnishing details like TIN number, VAT/CST number, Bank address with EFT Account if applicable, etc and complete postal & e-mail address of their office.
- 8. <u>Clarification regarding contents of the RFP</u>: A prospective bidder who requires clarification regarding the contents of the bidding documents shall notify to the Buyer in writing about the clarifications sought not later than 07 (seven) days prior to the date of opening of the Bids
- 9. Modification and Withdrawal of Bids: A bidder may modify or withdraw his bid after submission provided that the written notice of modification or withdrawal is received by the Buyer prior to deadline prescribed for submission of bids. A withdrawal notice may be sent by fax but it should be followed by a signed confirmation to be wester, Newsent by post and such signed confirmation should reach the purchaser not later than the deadline for submission of bids. No bid shall be modified after the deadline for submission of bids. No bid may be withdrawn in the interval persent in deadline for

submission of bids and expiration of the period of bid validity specified. Withdrawal of a bid during this period will result in Bidder forfeiture of bid security.

- 10. <u>Clarification regarding contents of the Bid</u>: During evaluation and comparison of bid, the Buyer may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained.
- 11. <u>Rejection of Bids</u>: Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection with forfeiture of EMD. Conditional tenders will be rejected.
- 12. <u>Unwillingness to quote</u>: Bidder unwilling to quote should ensure that intimation to this effect reaches before the due date and time of opening of the Bid, failing which the defaulting Bidder may be de-listed for the given range of items as mentioned in this RFP.
- 13. <u>Validity of Bids</u>: The Bids should remain valid till 04 months from the last date of submission of the Bids.
- Earnest Money Deposit: Bidder is required to submit Earnest Money Deposit (EMD) for amount of Rs 70,000/- (Rupees Seventy Thousand only). The EMD may be submitted in the form of an Account Payee Demand Draft, Fixed Deposit Receipt, Banker's cheque or Bank Guarantee from any public sector banks or private sector bank authorized to conduct government business as per Form DPM-16 (Available in MoD website and can be provided on request). EMD is to be valid for a period of fortyfive days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidders would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. However, EMD is not required to be submitted by those Bidders who are registered with the Central Purchase Organization (e.g. DGS&D), National Small Scale Industries Corporation (NSIC) or any department of MoD or MoD itself. The EMD will be forfeited if the bidder withdraws or amends impairs or derogates from the tender in any respect within the validity period of their tender.



Part III - Standard Conditions of RFP

The Bidder is required to give confirmation of their acceptance of Special Conditions of the RFP mentioned below. Failure to do so may result in rejection of Bid submitted by the Bidder.

- 1. <u>Law</u>: The Contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.

Access to Books of Accounts: In case it is found to the satisfaction of the Buyer that the Seller has engaged an Agent or paid commission or influenced any person to obtain the contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the Seller, on a specific request of the Buyer, shall provide necessary information/ inspection of the relevant financial documents/information.
- 7. **Non-disclosure of Contract documents**: Except with the written consent of the Buyer/ Seller, other party shall not disclose the contract or any provision, specification, plan, design, pattern, sample or information thereof to any third party.
- 8. <u>Liquidated Damages</u>: In the event of the Seller's failure to deliver the product within delivery period mentioned in this RFP, the BUYER may deduct from the SELLER as agreed, liquidated damages to the sum of 0.5% of the quoted price of the item for each week thereof subject to a maximum value of 10%.
- 9. <u>Cancellation of order</u>: The Buyer shall have the right to cancel the order in any of the following cases:-
 - (a) The delivery of the material is delayed for causes not attributable to Force Majeure for more than 01 (one) month after the scheduled date of delivery.
 - (b) The Seller is declared bankrupt or becomes insolvent.
 - (c) The delivery of material is delayed due to causes of Force Majeure by more than 06 (six) months.
 - (d) The Buyer has noticed that the Seller has utilised the services of any Indian/Foreign agent in getting this tender and paid any commission to such individual/company etc.

The Seller shall indemnify the Buyer against all claims from a third party at any time on account of the infringement of any or all the rights mentioned in the previous paragraphs, whether such claims arise in respect of manufacture or use. The Seller shall be responsible for the completion of the supplies including spares, tools, technical literature and training aggregates irrespective of the fact of infringement of the supplies, irrespective of the fact of infringement of any or all the rights mentioned above.
- 13. Amendments: No provision of present Contract shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.
- 14. **Taxes and Duties** (Will be provided as per extant rules)
 - If Bidder desires to ask for Duty/Tax/GST extra, the same must be specifically stated. In the absence of any such stipulation, it will be presumed that the prices include all such charges and no claim for the same will be entertained.
 - (b) If reimbursement of any Duty/Tax/GST is intended as extra over the quoted prices, the Bidder must specifically say so. In the absence of any such stipulation it will be presumed that the prices quoted are firm and final and no claim on account of such duty/tax/GST will be entrained after the opening of tenders.
 - (c) If a Bidder chooses to quote a price inclusive of any duty/tax/GST and does not confirm inclusive of such duty/tax/GST so included is firm and final, he should clearly indicate the rate of such duty/tax/GST and quantum of such duty/tax/GST included in the price. - 2. Option Clause: The contract will have an Option Clause, wherein the Buyer can exercise an option to procure an additional 50% of the original contracted quantity in accordance with the same terms & conditions of the present contract. This will be applicable within the currency of contract. The Bidder is to confirm the acceptance of the same for inclusion in the contract. It will be entirely the discretion of the Buyer to exercise this option or not.
- Repeat Order Clause: The contract will have a Repeat Order Clause, wherein the Buyer can order upto 50% quantity of the items under the present contract within six months from the date of supply/successful completion of this contract, the cost, terms & conditions remaining the same. The Bidder is to confirm acceptance of this clause. It will be entirely the discretion of the Buyer to place the Repeat order or not.
- 4. Tolerance Clause: To take care of any change in the requirement during the period starting from issue of RFP till placement of the contract, Buyer reserves the right to 50% plus/minus increase or decrease the quantity of the required goods upto that limit without any change in the terms & conditions and prices quoted by the Seller. While awarding the contract, the quantity ordered can be increased or decreased by the Buyer within this tolerance limit.
- 5. - (a) Neither party shall bear responsibility for the complete or partial nonperformance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.
- (b) In such circumstances the time stipulated for the performance of an obligation under the present tender is extended correspondingly for the period of time of action of these circumstances and their consequences.
- (c) The party for which it becomes impossible to meet obligations under this contract due to Force Majeure conditions, is to notify in written form the other party of the beginning and cessation of the above circumstances immediately, but in any case not later than 10 (Ten) days from the moment of their beginning.
- (d) Certificate of a Chamber of Commerce (Commerce and Industry) or other competent authority or organization of the respective country shall be a sufficient proof of commencement and cessation of the above circumstances.
- If the impossibility of complete or partial performance of an obligation lasts for more than 6 (six) months, either party hereto reserves the right to terminate the order totally or partially upon giving prior written notice of 30 (thirty) days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.
- Buy Back Offer. Buyer is interested to trade the BER declared servers (without harddisk) while purchasing the new ones. Bidders may formulate and submit their tenders accordingly. The servers will be traded without the Harddisk. Interested Bidders can inspect the old goods to be traded through this transaction. Buyer reserves its right to trade or not to trade the BER declared servers while purchasing the new ones and the Bidders are to frame their bids accordingly covering both the options. - 12. Specification: The following specification clause will form part of the contract placed on successful Bidder - The Seller guarantees to meet the specifications as per Part-II of RFP and to incorporate the modifications to the existing design configuration to meet the specific requirement of the Buyer. All technical literature and upgrades to the product shall be carried out as modifications by the Seller before supply to the Buyer. The seller in consultation with the Buyer, may carry out technical upgradation/alterations in the design, drawings and specifications due to change in manufacturing procedures. This will, however not in any way, adversely affect the end specifications of the product. Changes in technical details, drawings, repair and maintenance techniques alongwith necessary result upgradations/alterations will be provided to the Buyer free of cost within 30 days of affecting such upgradation/alterations.
- 13. <u>OEM Certificate</u>: In case the Bidder is not the OEM of the product, the bidder should attach the supporting documents as an authorized dealer/Valid partner certificate from the OEM authorizing the firm to undertake supply of above items.
- 14. <u>Earliest Acceptable Year of Manufacture</u>: The item should be of latest version, conform to current production standard and should have 100% defined life at the time of delivery. Deviations, if any, should be clearly brought out by the vendor in the technical proposal.
- 15. <u>Transportation:</u> The following Transportation clause will form part of the NIRUDDH contract placed on successful bidder:-

Lt Cdr, System Manager (CIF/CIP: The stores shall be delivered CIF/CIP to WESEE. Seller will bear the costs and freight necessary to bring the items to WESEE. The seller has to procure Road Transport insurance against the Buyer's risk of loss or any damage to items during the transportation to the Buyer.  - (a) The Seller shall provide packing and preservation of the items mentioned at Para 1 Part II and spares/goods contracted so as to ensure their safety against damage in the conditions of land, sea and air transportation, transhipment, storage and weather hazards during transportation, subject to proper cargo handling.
 - (b) The packing of the product and spares/goods shall conform to the requirements of specifications and standards in force in the territory of the Seller's country.
 - (c) The Seller shall mark each package with in the English language as follows:-

- (d) Should any special product be returned to the Seller by the Buyer, the latter shall provide normal packing, which protects the product and spares/goods from the damage of deterioration during transportation by land, air or sea. In this case the Buyer shall finalize the marking with the Seller.
- 17. **Quality**: The quality of the items delivered according to the present Contract shall correspond to the technical conditions and standards or specifications enumerated as per RFP and shall also include therein modification to the items mentioned at Para 1 Part II suggested by the Buyer. Such modifications will be mutually agreed to. The Seller confirms that the stores to be supplied under this Contract shall be new and shall incorporate all the latest improvements and modifications.
- 18. **Quality Assurance**: The item should be of the latest manufacture, conforming to the current production standard and having 100% defined life at the time of delivery.
- 19. <u>Inspection:</u> The inspection will be carried out by the Buyer at Buyer premises. The mode of inspection will be User Inspection.
- 20. <u>Franking clause</u>: The following Franking clause will form part of the contract placed on successful Bidder:-
 - (a) Franking Clause in the case of Acceptance of Goods: "The fact that the goods have been inspected after the delivery period and passed by the Inspecting Officer will not have the effect of keeping the control of the Burns, under the goods are being passed without prejudice to the rights of the Burns, under the terms and conditions of the contract".

- (b) Franking Clause in the case of Rejection of Goods: "The fact that the goods have been inspected after the delivery period and rejected by the Inspecting Officer will not bind the Buyer in any manner. The goods are being rejected without prejudice to the rights of the Buyer under the terms and conditions of the contract."
- 21. <u>Claims</u>: The following claims clause will form part of the contract placed on successful Bidder:-
 - (a) The claims may be presented either: (i) on quantity of the product, where the quantity does not correspond to the quantity shown in the Packing List/Insufficiency in packing, or (ii) on quality of the product, where quality does not correspond to the quality mentioned in the contract.
 - (b) The quantity claims for deficiency of quantity shall be presented within 45 days of completion of acceptance of goods. The quantity claim shall be submitted to the Seller as per Form DPM-22 (Available in MoD website and can be given on request).
 - (c) The quality claims for defects or deficiencies in quality noticed during the acceptance shall be presented within 45 days of completion of acceptance of goods. Quality claims shall be presented for defects or deficiencies in quality noticed during warranty period earliest but not later than 45 days after expiry of the guarantee period. The quality claims shall be submitted to the Seller as per Form DPM-23 (Available in MoD website and can be given on request).
 - (d) The description and quantity of the stores are to be furnished to the Seller along with concrete reasons for making the claims. Copies of all the justifying documents shall be enclosed to the presented claim. The Seller will settle the claims within 45 days from the date of the receipt of the claim at the Seller's office, subject to acceptance of the claim by the Seller. In case no response is received during this period the claim will be deemed to have been accepted.
 - (e) The Seller shall collect the defective or rejected goods from the location nominated by the Buyer and deliver the repaired or replaced goods at the same location under Seller's arrangement.
 - (f) Claims may also be settled by reduction of cost of goods under claim from bonds submitted by the Seller or payment of claim amount by Seller through demand draft drawn on an Indian Bank, in favour of Principal Controller/Controller of Defence Accounts concerned.



22. Warranty:

(ANIRUDDH PAN

(a) The supplied item shall carry a warranty of 36 months from the date of acceptance of item or date of commissioning, which we have the item supplied under the supply order and each component used in the item should be free from all types of defects/failures.

- (b) The Seller shall warrant that the item supplied conform to technical specifications prescribed and shall perform according to the said Technical Specifications in this RFP.
- (c) If within the period of warranty, the item reported by the Buyer to have failed to perform as per the specifications, the Seller shall either replace or rectify the same free of charge, maximum within 05 days of notification of such defect received by the Seller. Warranty of the product would be extended by such duration of downtime. Record of the down time would be maintained by user in log book. The seller also undertakes to diagnose, test, adjust and replace the product arising due to accidents by neglect or misuse by the operator or damage due to the transportation of the product during the warranty period, at the cost mutually agreed to between the buyer and the seller.
- (d) Seller shall warrant that necessary service and repair back up during the warranty period of the product shall be provided by the Seller and he will ensure that the downtime is not more than 05 days of the warranty period.
- (e). Seller shall associate technical personnel of Maintenance agency and Quality Assurance Agency of the Buyer during warranty repair and shall also provide the details of complete defects, reasons and remedial actions for defects.
- (f) If the product fails frequently and the cumulative down time exceeds 50% of the warranty period, the complete product shall be replaced free of cost by the Seller within a stipulated period of 15 days of receipt of the notification from the Buyer. Warranty of the replaced product would start from the date of acceptance after Joint Receipt Inspection by the Buyer/date of installation and commissioning.
- 23. <u>Product Support</u>: The Seller shall provide product support in terms of maintenance activities and repairs / trouble-shooting free of cost during the warranty period.
- 24. <u>Technical Documentation</u>: All necessary documentation (Technical and User manual) for using the product has to be provided by the bidder.





Part V - Evaluation Criteria & Price Bid issues

- 1. <u>Evaluation Criteria</u>: The broad guidelines for evaluation of Bids will be as follows:
 - (a) Only those Bids will be evaluated which are found to be fulfilling all the eligibility and qualifying requirements of the RFP, both technically and commercially.
 - (b) The Bidders are required to spell out the rates of Customs duty, Excise duty, VAT, Service Tax, GST etc in unambiguous terms; otherwise their offers will be loaded with the maximum rates of duties and taxes for the purpose of comparison of prices. If reimbursement of Customs duty / Excise Duty / VAT/ GST is intended as extra, over the quoted prices, the Bidder must specifically say so. In the absence of any such stipulation it will be presumed that the prices quoted are firm and final and no claim on account of such duties will be entrained after the opening of tenders. If a Bidder chooses to quote a price inclusive of any duty and does not confirm inclusive of such duty so included is firm and final, he should clearly indicate the rate of such duty and quantum of excise duty included in the price. Failure to do so may result in ignoring of such offers summarily. If a Bidder is exempted from payment of Customs duty / Excise Duty / VAT/GST duty upto any value of supplies from them, they should clearly state that no excise duty will be charged by them up to the limit of exemption which they may have. If any concession is available in regard to rate/quantum of Customs duty / Excise Duty / VAT/GST, it should be brought out clearly. Stipulations like, excise duty was presently not applicable but the same will be charged if it becomes leviable later on, will not be accepted unless in such cases it is clearly stated by a Bidder that excise duty will not be charged by him even if the same becomes applicable later on. In respect of the Bidders who fail to comply with this requirement, their guoted prices shall be loaded with the quantum of excise duty which is normally applicable on the item in question for the purpose of comparing their prices with other Bidders. The same logic applies to Customs duty and VAT also.
 - (c) If there is discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price will prevail and the total price will be corrected. If there is a discrepancy between words and figures, the amount in words will prevail for calculation of price.
- (d) The Lowest Acceptable Bid will be considered further for placement of (ANIRUDDH PANSupply Order after complete clarification and price negotiations as decided by Lt Cdr, System Mathe Buyer.
