Sealed tenders are invited from eligible Tenderers under two-bid system for the work of "Geotechnical Investigation for DC-02 works for Project Seabird Phase IIA, at Karwar." as per the details furnished hereunder:

Cost of tender document: Non-transferable tender documents with relevant details can be obtained from the office of DG, Project Seabird, West Block V, RK Puram, New Delhi 110066 between 30-Oct-2019 (Wed.) to 13-Nov-2019 (Wed.), during working hours, on payment of non-refundable fee of Rs. 3,000/- in the form of Demand Draft drawn in favour of Director General Project Seabird New Delhi payable at New Delhi.

**EMD**: Rs. 2,37,000/- (Rupees Two Lakhs and Thirty Seven Thousand only) in favour of Director General Project Seabird New Delhi-110066. EMD will be submitted along with offer in the form of FDR/Bankers cheque/Bank Guarantee from any Indian Nationalised Bank/Scheduled commercial Bank permitted to carryout business in India. Exemption from submission of EMD is allowed for registered Micro and Small Enterprises, as per Public Procurement Policy for Micro and Small Enterprises (MSEs) Order 2012 against valid registration certificate.

**Site of Work**: Naval Base at Karwar, the northern-most point of which is located approximately 110 kilometers south of Panaji, Goa on the Western Coast of India.

#### Completion period:

- a) The Stage-1 shall be completed along with submission of final detailed report within 12 weeks from the 'Commencement Date'.
- b) The Stage-2A shall be completed along with submission of final detailed report within 04 weeks from handing over of site for Stage-2A work after completion of the Reclamation work.
- c) The Stage-2B shall be completed along with submission of final detailed report within 05 weeks from handing over of site for Stage-2B work after completion of the Reclamation work.

A minimum notice of a month's time shall be given to the successful Tenderer to remobilise and commence Stage-2A work and also for Stage-2B work.

### 1. QUALIFICATION CRITERIA:

### (a) MINIMUM AVERAGE ANNUAL TURNOVER

The tenderer should have an average annual turnover (inclusive of Goods & Services Tax and/ or Service Tax) of at least Rs. 35,40,000/- during the last 3 financial years (ending as on 31st March 2019).

- a) The above information is to be submitted in the attached FORM-I.\*
- b) The Bidders should note that the average turnover shall be calculated by adding

c) Documentary proof for turnover such as audited balance sheet, profit & loss account statement for annual turnover shall be submitted with the tender (copies duly notarised).

#### (b) SIMILAR WORK EXPERIENCE

The tenderer should have successfully completed "similar works" of values listed below during the last seven (07) years (ending as on the preceding month of the month of this tender issue).

- a) Three similar completed works each costing not less than Rs. 47,20,000/-. (or)
- b) Two similar completed works each costing not less than Rs. 59,00,000/-.
