- 2. All the firms were informed that in Appendix C the Serial 13 (12V 75AH UPS) has been erroneously missed. Firms may please take note of the same and add the serial in their price bid while submitting the quotations. Also submission of following additional documents is mandatory:-
 - (a) Certificate from OEM stating that the firm is their authorised channel partner or dealer.
 - (b) Lab test report from STQC/ETDC regarding testing of battery.

- 3. The queries made by vendors and their respective explanation are mentioned below:-
 - (a) UPS Batteries (SMF) of 180 AH and 135 AH are generally not available in the market as they are not of standard make.

<u>Clarification</u> There is no change in requirement it will be same as per RFP.

(b) Make and Model of the batteries is not mentioned in the RFP.

<u>Clarification</u> As per extant government policy make and model can't be specified in the RFP.

(c) Is certificate from OEM to be submitted stating that the firm is their authorised channel partner or dealer?

<u>Clarification</u> Yes, submission of OEM certificate stating that the firm is their authorised dealer/channel partner is mandatory and the certificate should be submitted along with the technical bid. Failure to submit the certificate will lead to rejection of firms bid.

(d) Is any certificate regarding quality or testing of battery to be submitted?

<u>Clarification</u> Yes, firm has to submit the STQC (Standardisation Testing and Quality Certification)/ETDC(Electronic Test and Development Centre) certificate for the battery quoted by the firm. Non submission of certificate will lead to rejection of bid.

(e) Whether the contract is for 1 year or 3 years?

<u>Clarification</u> Initially the contract will be concluded for one year and will be extendable for further period of two years subject to satisfactory performance of the firm. However, the firm should work out its cost and submit bid as a three year contract.

(f) The GST on purchase of new battery is 28% and GST on purchase of old battery is 18%. Therefore the format for submission of price bid be changed?
