TENDER NOTICE

1. Tenders are invited in two bid system (Technical and Commercial) from **reputed Boat suppliers** for supply of “**COACH BOATS FOR INWTCs AND TRAINING ESTABLISHMENTS**”.
2. The Terms & Conditions and Tender Document can be obtained from **Indian Naval Sailing Association**, located at **IHQ MOD (Navy)/ INSA, 7th Floor, Chanakya Bhawan, Chanakyapuri, New Delhi – 110021** or **may be downloaded from Indian Navy website <http://www.indiannavy.nic.in>**. The cost of the tender document is Rs 1000/- (Rupees One thousand only) (non-refundable) which is to be paid in form of Demand Draft drawn in favour of “**PCDA (Navy)**” payable at New Delhi either while collecting the tender document or while submission of the bid (in case document is downloaded from the website).
3. All completed tender documents (Technical as well as Commercial bids) should be submitted along with an Earnest Money Deposit (EMD) for an amount Rs **6,30,000.00** (Rupees **Six lakhs thirty thousand** only). The EMD may be submitted in the form of an Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee in favor of ‘**PCDA Navy**’, payable at New Delhi from any of the public sector banks or a private sector bank authorized to conduct government business as per Form DPM-16 (Available in MoD website and can be provided on request). EMD is to remain valid for a period of forty-five days beyond the final bid validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The Bid Security of the successful bidder would be returned, without any interest whatsoever, after the receipt of Performance Security from them as called for in the contract. EMD is not required to be submitted by those Bidders who are registered for the same Items/range of products/goods or services from the Central Purchase Organization (e.g. DGS&D), National Small Industries Corporation (NSIC) or any Department of MoD or MoD itself. The EMD will be forfeited if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of their tender. If EMD is not found enclosed with the tender document, except for exempted vendors, such offers would not be considered and would be treated as technically rejected.

4. The last date of submission of quotes is **1000 hrs on 26 Aug 17**. The '**Technical Bid**' will be opened on **at 1030 hrs on 26 Aug 17** in the same office. The 'Commercial Bids' of firms who qualify technical evaluation by TEC, will be opened subsequently. Date and time for the same will be intimated to all concerned. Tenders found incomplete or received late, will be rejected and no further correspondence on this matter will be entertained. The department reserves the right to reject any or all tenders without assigning any reason thereof. Conditional tenders will not be accepted.
5. The Tenders or their duly authorised representatives are permitted to be present during the opening of the '**Technical Bids**' and the '**Commercial Bids**', as stated above.
