- (a) The direct recruitment post in Gp 'C' services are in the same line or allied cadres and a relationship could be established that service rendered in the Department/Posts will be useful for efficient discharge of the duties in the other categories of post.
- (b) Where an employee has rendered not less than three years continuous service under Government (and not on ad-hoc basis) as on the last date of submission of application will be eligible for relaxation wherever as applicable in the column 03 of Para 1(a) to (l) above.
4. Age, Educational qualification and all other eligibility criteria will be considered as on **27 Feb 2015**.
5. **LAST DATE:** The last date of receipt of application as per advertisement No 43/10 published in Employment News dated 24-30 Jan 2015 was **27 Feb 2015**. The same has been extended upto **31 Mar 2015 due to issue of corrigendum**. Similarly, the last date of receipt of application from the candidates residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State Lahaul and Spiti District and Pangti sub-division of Chamba District of Himachal Pradesh, Andaman and Nicobar Islands or Lakshadweep was **06 Mar 2015** and the same has been extended upto **07 Apr 2015**. Applications received after last date will not be considered. Though the last date of receipt of applications has been extended, the crucial date for determining age, educational qualifications and other eligibility conditions will continue to be as on **27 Feb 2015**.
6. **HOW TO APPLY:** The application should be on plain paper (A4 Size) (good quality paper should be used) either neatly hand written or typed as per the prescribed Format, affixed with latest passport size colour photograph duly attested by Gazetted Officer in the space provided. The envelope must be superscribed on the top as "APPLICATION FOR THE POST OF _____", and CATEGORY "_____" (i.e. SC/ST/OBC/UR/Ex-Serviceman) and sent by **Registered/Speed Post**
7. The application form should be filled by the candidate in his own handwriting in Capital Letters only.
8. Candidates applying for more than one post should submit separate application for each post.
9. **WHOM TO ADDRESS:**

10. **GENERAL CONDITIONS:**
- (a) The vacancies shown above are provisional and may be increased /reduced or even made NIL without assigning any reason.
- (b) The Competent Authority reserves the right to select the criteria for short listing of candidates for Written Examination/Interview/Skill Test for the above posts. Competent Authority also reserves the right to cancel part or whole of any recruitment process at any stage for any of the categories in this employment notification without assigning any reason thereof.
- (c) Experience should be after acquiring education qualification/license of appropriate category (wherever applicable) part time experience will not be taken into consideration.
- (d) Incomplete application, applications with insufficient details or in other than the format prescribed will be summarily rejected.
- (e) Ex Servicemen candidates are to produce certificate in support of their claim and meet Govt. orders on qualifying as Ex. Servicemen.
- (f) Candidates working in Govt. establishment, public sector undertakings and autonomous bodies should apply through proper channel and should submit "No Objection Certificate" at the time of interview.
- (g) The definition of categories of the physically handicapped for the purpose of reservation in employment as per GOI DOP&T Order OM No. 36035/14/95-Estt(Res) dated 27-02-1996 read with OM 36035/2/98-Estt(Res) dated 04-06-1998 or as modified from time to time.

SC/ST candidates to produce certificate in support of their claim and attested copy of certificate in the prescribed form issued by the Competent Revenue Authority not below the rank of Tahsildar/Mandal/Revenue Divisional Officer.

(j) Submission of false/incorrect/incomplete and/or dubious/bogus documents shall disqualify the candidate.

(k) SC/ST candidates shall be paid second class TA as admissible under the rules on production of Bus/Train ticket for the nearest route as per existing rules.

(l) Canvassing in any form and/or bringing in any influence, political or otherwise will be a disqualification for the test/post.

(m) Only selected candidates will be informed of their selection in due course after the selection process and no other correspondence on the subject would be entrained.

(n) **Selected candidates are liable to serve anywhere in India including any Naval unit within Eastern Naval Command/Andaman & Nicobar Command. Those who are willing to serve anywhere in India should only apply.**

(p) **Candidates are requested to ensure that they fulfill the eligibility conditions before applying for the above posts.**

(q) **No relaxations in the upper age limit is admissible for SC/ST/OBC candidates applying for UR vacancies**

(r) **No age relaxation is admissible to sons/daughters of Ex/ Servicemen.**

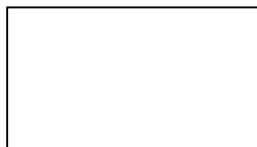
